



## Scott City Parks and Recreation Private Pool Party Reservation

Private pool parties can be reserved after hours on Friday, Saturday, or Sunday evenings:

Friday: 7-9PM

Saturday: 7-9PM

Sunday: 11AM – 1PM or 7-9PM

\*Other days and times can be made available upon request, at the discretion of the Parks Director and swim team\*

**Rental fee is \$120.00 for a 2-hour party**

### Terms

1. The party of record for the reservation are required to be present at the pool throughout the reservation time and are responsible for their guests.
2. For safety reasons, a maximum of 75 guests are permitted in the entire facility for the reservation.
3. There will be a minimum of one lifeguard on duty. This lifeguard is in charge and should be treated with respect and obeyed.
4. The concession stand will be closed. The reservation party and their guests may bring refreshments and food items.
5. Food and drink must stay in concession stand area. Absolutely no food or drink in or around pool.
6. Glass containers are strictly prohibited.
7. The Scott City Community Pool is an alcohol and tobacco-free zone. No exceptions. Violators will be asked to leave.
8. Guests under the influence of alcohol or drugs will be asked to leave the facility.
9. In the event of inclement weather the reservation may be rescheduled free of charge or cancelled. To be eligible for a refund, there must be at least a 2 hour notice on a cancellation. Reservations cannot be cancelled or rescheduled after the scheduled start time and no refunds will be given.
10. In the event of dangerous weather or other conditions, all guests will evacuate the pool at the discretion and direction of the lifeguard on duty. Lifeguards will close the pool during inclement weather and have all guests return to their vehicles. If the pool is closed for longer than one hour, the reservation will end.
11. Guests shall not enter the pool until the scheduled start time. The reserving party only may enter the pool area no earlier than 30 minutes prior to start time.
12. The reserving party and all guests must be out of the facility no later than 30 minutes after the scheduled end time. No loitering anywhere in the facility after this time.
13. The reserving party is responsible for ensuring that the pool, deck area, and locker rooms are clean and free of trash before leaving.
14. Children in the smaller wading pool must be supervised by an adult. All children in diapers or training pants must be using 'swimmers.'
15. Refusal to abide by these terms and conditions may result in loss of privileges to attend the Scott City Community Pool.
