

SCOTT CITY COUNCIL MEETING

June 15th, 2020

Call to order: A meeting of the Council was held on June 15th, 2020 in the Council Chambers located at City Hall, 215 Chester Ave. Mayor Norman Brant called the meeting to order at 7:00 PM. Motion to approve Liquor License renewals for Knights of Columbus, Rhodes 101 Stop/Travel Center, Schock's Pub, The Front Porch, Bob's Foodliner, Casey's and KP was made by Councilman Mike Rhymer; Seconded by Councilman Victor Phillips. 3 AYE, 2 NAYES; Motion Carried.
