4.) **Bill #1253; Ordinance #1262:** An ordinance of the City of Scott City, Missouri, Imposing a Use Tax for General Revenue Purpose at the rate equal to the total local sales taxes in effect for the privilege of storing, using or consuming within the city any article of tangible personal property pursuant to the authority granted by and subject to the provisions of sections 144.600 through 144.761 RSMO; providing for the Use Tax to be repealed, reduced or raised in the same amount as any city sales tax is repealed, reduced or raised; and providing for submission of the proposal to the qualified voters of the city for their approval at the special election called and to be held in the city on April 5, 2022.

5.) **Resolution 622:** A resolution of the City of Scott, Missouri, stating intent to seek funding through the community development block grant program and authorizing the mayor to pursue activities in an attempt to secure funding.

6.) **Resolution 623:** A resolution extending the City's liability insurance with MOPERM for the calendar year 2022

7.) **Resolution 624:** A resolution authorizing the City of Scott City to extend its health coverage with Anthem Blue Cross Blue Shield to allow time for market comparisons.
