SCOTT CITY COUNCIL MEETING

September 19th, 2022

Call to order: A meeting of the Council was held on Tuesday, September 19th, 2022, in the Council Chambers located at City Hall, 215 Chester Ave. Mayor Pro Tem Randy Morse called the meeting to order at 7:00 PM.
